## Sierra Valley Preserve & Nature Center Summer Internship Job Description

**PROGRAM ELIGIBILITY:** This position is offered as part of FRLT's community outreach program at the Sierra Valley Preserve to offer meaningful pathways to careers in land conservation, stewardship, and public education. The role is open to youth ages 17 to 19 who are currently enrolled in or have recently graduated from a public high school in Plumas or Sierra County.

**POSITION:** Seasonal Summer Internship (paid) **AGE REQUIREMENT:** 17 years or older

**COMPENSATION:** \$16.90 per hour **LOCATION:** Sierra Valley Preserve, Beckwourth, CA (onsite), with occasionally work at other FRLT-protected properties around the region.

**JOB CLASSIFICATION:** This is a temporary, seasonal position and does not provide any entitlement to regular paid employment, benefits available to regular FRLT employees (except as required by law) or a future job.

**TERM:** May 1 – August 15. For enrolled high school students, hours will be limited to a maximum of 18 hours during the school year (May 1-June 12<sup>th</sup> or according to school schedule).

**WORK SCHEDULE:** 25-32 hours per week during summer months, as assigned by manager, including frequent work on Saturdays and Sundays.

### **ABOUT THE JOB**

Feather River Land Trust (FRLT) owns and manages the Sierra Valley Preserve and Nature Center, a 2,575-acre nature preserve located near Beckwourth, CA. The Preserve features outdoor recreation areas with parking and restrooms, interpretive trails, a wildlife overlook, and picnic areas. The Nature Center offers a variety of nature-based events for schools and the public. This is an opportunity for a young person to make a meaningful impact in a local conservation nonprofit in their community and build skills including teamwork, personal responsibility, and public service.

### **JOB DUTIES**

The Intern will work at the intersection of land stewardship and public programs and will receive training and support in their duties from the Land Stewardship Team and Public Programs Manager.

#### **Nature Center and Public Programs Support**

- Provide support to the Public Programs Manager for events including planning, registration, setup, cleanup, guest and speaker support
- Respectfully engage visitors and provide helpful information
- Take photos at events, help create and post event flyers and help with other communications and marketing (if this is an area of skill/interest).

### **Land Stewardship & Facilities Maintenance**

- Help maintain trails, trailheads, and overlooks and improve public facilities
- Patrol properties, filling out patrol logs and supporting monitoring
- Keep the Preserve facilities clean and maintained including cleaning indoor and outdoor facilities (benches, signs, exhibits, restrooms, kitchen, floors, etc.)
- Care for the land including invasive weeds management and supporting restoration and agriculture projects.

### **Administrative Support**

- Review and catalog images
- Scan and file office documents
- Participate in team meetings and activities
- **Special projects of interest to the intern may be accommodated based on staff capacity to support.**

### **QUALIFICATIONS & ABILITIES:**

- Be a high school student or recent graduate (preferably of a Plumas or Sierra county school)
- Must be at least 17 years old
- Must have a Social Security card or have applied for one
- Must have a valid driver's license, a clean driving record, and a vehicle to drive to work daily
- Youth must receive a permit to work
- Interest in conservation, land stewardship, nonprofits, education, and/or community events
- Willingness to work hard, collaborate with others, and learn new things
- Responsible and able to interact with the public in a friendly and helpful manner
- Ability to use computers (experience with email, Microsoft Word, and any other software or web-based platforms is a plus)

### **DAILY PHYSICAL DEMANDS INCLUDE:**

- Ability to stand for extended periods of time
- Ability to work in an indoor and outdoor environment, including on undeveloped land
- Reach with hands and arms
- Walk, climb, or balance and stoop
- Ability to lift up to 50 pounds, over rough terrain when necessary
- The ability to inspect, identify, observe, and assess safety situations in all work environments

- Working environment may include unpredictable weather conditions, walking on uneven ground, and working outdoors for extended periods of time
